All the Principals of Pharmacy Colleges are hereby informed that the **Practical Examinations** in Second Half of 2016 for M.Pharmacy will be conducted from 4<sup>th</sup> December to 11<sup>th</sup> December 2016 at all approved centers:

The centers shall follow the following instructions for the conduct of the said

**Examinations :**

1. The list of examiners and course wise number of students for the practical examinations will be given to the Principal of examination centre by the University.
2. Principal of the examination center shall see that the batch size for practical examination should not exceed 20 students.
3. The principal of the respective examination center shall prepare the timetable of practical examination as per the availability of the examiners and submit the hard copy of the time table to Controller of Examinations as well as soft copy to the respective Co-ordinators and Dean faculty of Pharmaceutical Sciences by email on or before 4<sup>th</sup> December 2016. The list of examiners appointed for the practical examination shall be communicated to the respective co-ordinator by email on or before 4<sup>th</sup> December, 2016.
4. The practical examination shall be conducted as per the time table submitted.
5. If the examiner appointed by the University fails to conduct the examination, in such cases alternative examiner shall be appointed by the Principal in consultation with respective co-ordinator appointed for the respective region. It is mandatory to take consent from the Co-ordinator by mail and same should be submitted along with marksheet.

6. The Principal of the Examination center shall also see that examiner appointed should be strictly P.G. Recognized Teacher of Savitribai Phule Pune University or any other University
7. The Principal of the respective Examination Centre shall submit the Marksheet of the practical examination Online and Print Copy duly signed by the examiners to the Controller of Examinations immediately after the completion of practical examination in that Centre.
8. The Principal of examination center shall also submit the exam co-ordinator report stating the list of examinations who have actually conducted the practical examinations to the Controller of Examinations and respective regional co-ordinators.
9. Hall tickets and examination summary is available on college login.

The Principal of the concerned college should take the print out of the hall ticket available on the college login and distribute the same to the respective students.
