ELIGIBILITY-

Category I: The competition is open for all students enrolled in a 5-year integrated undergraduate law program, 3 years L.L.B program in any University/College recognised by Bar Council of India.

Category - II: Any BA/BBA/BCom/ BSc/ BTech etc. undergraduate graduate students studying in College/University.

Theme –

CLOSING THE GENDER GAP IN IP – the “can do” attitude of women inventors, creators and entrepreneurs around the world and their ground-breaking work.

Guidelines for submission of the Essay –

- For law students - The essay must be at least 2000 – 2500 words (excluding footnotes)
- For undergraduate students - The essay must be at least 1000 – 1500 words (excluding footnotes)
- The Essay should be submitted in MS Word format with 1.5 line spacing from the main text.
- The participant must use the font TIMES NEW ROMAN with the font size of 12. The first page of Essay must have the full name, current year of study, name of the course the participant belongs to, email ID, phone number and name of the participant’s Law School/University.

- The theme or related area mentioned above must be followed or else the participant shall be disqualified.
- All submissions must be original and bonafide work of the participant and should not be submitted for any other competition or for any other purpose. Plagiarism is not accepted.
- Original views are strongly encouraged than excessive citation of published public information.
- The Essay should not contain any provocative language or should not be instigate any type of political or religious hate. (If any of the abovementioned found, the participant shall be disqualified from the competition).
- No joint submissions are permitted.
- Language – English
- The Essay must be submitted on/before the 20 of April, 2023 11:59 pm.
- No submissions will be entertained after the abovementioned deadline.

The best essay will be awarded with a cash prize and certificate of appreciation.

Guidelines for submission of the Poster –

- E-poster size: cm: (format W * H) 19.05 *33.87 cm.
- File size: Maximum file size is 4 Megabytes (4MB)
- File Format: Save your file as a PDF for a quick and easy upload.
- Eac0068 participant must submit one entry only.
- Entries must be submitted by the __ of April, 2023 on/before 11:59 pm.
- The E-poster will be judged according to the following criteria: creativity, presentation and relevance to the theme.
- All poster entries must include the aforementioned theme or a related creative quotation in English.
- All E-posters should be original work of participant. Any participant found violating rules and regulations will be disqualified from competition
- No poster should include any image or name of government officials or popular personalities.
- The poster must be attractive in terms of design and neatness of presentation.

The best poster will be awarded with a cash prize and certificate of appreciation.

Category I - Law student

- Essay writing 1st prize – A cash price of Rs. 2000/- and a certificate of participation.
- Poster making 1st Prize - A cash price of Rs. 2000/- and a certificate of participation.

Category II - Undergraduate student
