Kindly refer to D.O. letter of even number dated 03.12.2024 (copy enclosed), related to organization of "Watershed Yatra", a mass outreach campaign to create awareness about the Watershed Development activities carried out under the Watershed Development Component of Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY 2.0) project areas.
