RECRUITMENT OF SPORTS PERSONS DURING F.Y. 2019-20

The appropriate authority has approved recruitment of outstanding sportspersons in **Clerical Cadre** during the Financial Year 2019-20. All Circles have been allotted vacancy of 3 sportspersons each.

As per the present policy of State Bank of India Sports Control Board (SCB), sportspersons having proficiency in only 6 games, viz. Basketball, Cricket, Football, Hockey, Volleyball and Kabaddi are considered for recruitment in the Bank on sports quota. Circle may decide games from among the above 6 games under which they propose to recruit the sportspersons, keeping in view the need for building Circle level teams.

2. Eligibility Criteria: The eligibility norms are as under:-

- i. **Age:** Between 18 and 26 years as on 01.04.2019. However relaxation in upper age will be permitted in case of reserved categories as per the guidelines issued by the GOI (Relaxation in upper age limit will be 5 years for SC/ST candidates and 3 years for OBC candidates).
- ii. **Educational Qualification:** Graduation (as is in regular appointments in clerical cadre).
- iii. **Sports Qualification:** Candidate should have represented the State in National event or the District in State level event or the University in an inter-university event with distinction or he/she was a member of combined University team. Priority may be given in same order. The sports achievements shall be in the immediate previous 2 years and sportsperson shall be an active player.

3. **Other Details:** The Circle CGM is the appointing authority for the recruitment of sportspersons in Clerical Cadre within the Circle. As approved by the appropriate authority the Circle shall arrange as under:

- Due publicity of the recruitment and identified games through Advertisement.
- The applications received will be scrutinised and shortlisted by a committee comprised of minimum 5 members of Circle Welfare Committee which will be headed by DGM & CDO of the Circle. The list of shortlisted candidates must have approval of President, Circle Welfare Committee. List of eligible candidates to be called for interview shall be prepared and letters will be issued to the applicants by HR Department of the Circle at least 20 days before the interview.

- The interviews will be held at LHO. The selection will be on merit. Since the recruitment is on the basis of sports qualification, maximum weightage should be given to this factor as well as age of candidates. The activeness of sportspersons, team spirit, knowledge of game, Age etc. should be judged properly during interview. Final merit list will be prepared on the basis of total of 100 marks. The distribution of marks is as under:



- The Interview Board will comprise of Chief General Manager of the Circle, senior most General Manager of the Circle and two eminent sportspersons of International / National repute. The Circle Management Committee will recommend and forward the names of such sportspersons for approval by the President, Sports Control Board at Corporate Centre.
- The candidates so selected may be offered appointment in the bank subject to completion of other formalities such as satisfactory reports from referees, medical examination and verification of antecedents etc.
- Those sportsperson who are already working in other Bank/ Organisation will be not be considered for recruitment unless their applications are routed through their current employer Bank/ organisation.
- Usual character verification and Medical tests to be done in respect of the candidates recruited. Recruitment will be done in the same manner as is done for the regular candidates selected for appointment.
- Sports/ Games certificate/ achievements may also be got verified by the Circle from the issuing authority independently.
- All appointees will have same probation period as regular candidates.
- Only Indian citizens will be eligible for appointment under this scheme.
- Certificate and credentials will have to be submitted by the candidates before appointment.

4. **Common dates for declaration of result and joining:** Common dates for declaration of result and joining shall be advised separately after the completion of the selection process.

5. Please arrange for completion of the selection process latest by 31.08.2019.
