Introduction:

The SPPU instituted the innovative Bachelor Degree known as B. A. (Liberal Arts)) to strengthen liberal arts education at the undergraduate level. SPPU is among the top universities in the country and has been in the forefront for initiating innovative programs. As a part of its mission to promote interdisciplinary studies at graduate and post- graduate level, IDSS has launched B. A. (Liberal Arts).

In an increasingly integrated and interconnected world, the ability to connect information dots and integrate knowledge driven insights has become crucial in many walks of social and professional life. Developing such ability is not an easy task. It requires an education that helps to see the world beyond the tight disciplinary boundaries. Considering the growing importance of liberal arts perspective in academics and industry worldwide, Savitribai Phule Pune University (SPPU) has launched a three years Bachelor's degree course in Liberal Arts i.e. B. A. (Liberal Arts) from July 2019. Conducted by Interdisciplinary School of Sciences (IDSS) the course aims to help students develop an integrated and interdisciplinary approach to knowledge and problem solving. It is the first full time graduate programme in Liberal Arts conducted by a public/state university in Maharashtra. It is also among the handful of bachelors programmes run on the SPPU campus.

Eligibility, Intake & Profile of Students

Educational background- Mixed group of students coming from Arts, Commerce and Science background who have passed 10+2 level examination Students belong to diverse economic and social strata- including disadvantaged stratum of the society. Also includes foreign students.

The Liberal Arts program is looking to admit students who are curious, analytical and eager to explore beyond the boundaries of specific disciplines. The course would admit 40 students per batch. The admission of the students is governed by the relevant regulations of Government of Maharashtra. Intake capacity of students of B. A. Liberal Arts course is 40. This includes the reservations as per the Govertnemt of Maharashtra rules and regulations. Students belonging to Foreign and PIO categories will be admitted over and above the above number.

Course Structure

Duration: The duration of B. A. (Liberal) Degree Program shall be of three years.

Medium of Instruction: The medium of instruction for the course shall be English.

The programme is spread over three years i.e. six semesters. It offers an exciting combination of diverse subjects. From the second years onwards, students engage intensely with a subject of their choice from the given set. Called as 'major', this intense engagement brings student at par with the graduation level knowledge in the chosen subject. This enables student to pursue a Master's course in that subject.

- Three years i.e. Six semesters. Based on the Credit Based Semester System
- Total of 120 credits spread over six semesters. Each semester is for 20 credits.
- Papers are for 3, 2 or 1 credit. One credit means 15 hours of teaching and 25 marks.
- Seven Padegogical Units: Core Papers, Major Paper, Minor Papers, Elective Papers, Skill Papers, Project and Internship

Dates for commencement and conclusion for the first and second terms will be declared by the University authorities. Terms can be kept by only duly admitted students. The term shall be granted only on minimum 75 percent attendance during the term.

104E- Appreciating Poetry:

Course description: Poetry is one of the oldest forms of literary expression. It is also the most personal engagement that one can have in literature. One who can appreciate poetry can come nearer to understanding, and containing life. Along with lecture method, some demonstrations and practical sessions on yogic postures will be undertaken. The course opens up career opportunities as yoga trainer, plus the added advantage of self-benefit.
